

# ANGUS NICHOLSON HONOURS SCHOLARSHIP IN SCIENCE CONDITIONS OF AWARD

## 1. INTRODUCTION

Each year the ANU College of Science and the ANU College of Health and Medicine ("the Colleges") may offer an award known as the Angus Nicholson Honours Scholarship in Science ("the award").

The objective of the award is to assist a student enrolled in the Honours Year of an undergraduate degree offered by the ANU College of Science or the ANU College of Health and Medicine who can demonstrate a passion for his or her chosen field of Science.

Funding for this award has been provided by Mr Jon Nicholson, in memory of his late father Dr Angus Nicholson who was a dedicated physicist.

## 2. BENEFITS

The value of the award is stated in your letter of offer. The duration of the award is two consecutive academic semesters. The award is paid in two equal instalments at the beginning of each semester unless otherwise stated in the letter of offer.

The recipient is responsible for making payment of all tuition fees by the prescribed date as set out by the University each session. Recipients of this award are responsible for the costs of books, study materials, accommodation and all other costs of study.

# 3. ELIGIBILITY

The award is available each year to a current or prospective ANU student who:

- a) is a domestic or international student
- b) has an outstanding academic record in science
- c) has a demonstrated passion for his or her chosen field of Science
- d) is eligible for enrolment or already enrolled at the University in the Honours year of an undergraduate degree offered by the ANU College of Science or the ANU College of Health & Medicine or an equivalent degree program at another tertiary educational institution.

## 4. APPLICATION

To be considered for the award applicants must:

- 1) Apply by written letter to <a href="mailto:coursework.scholarships@anu.edu.au">coursework.scholarships@anu.edu.au</a> setting out one's passion for science and one's academic achievements.
- 2) The applicant must also organise two references from people who are well placed to support the application and comment on this passion, and arrange for referees to send their reports to <a href="mailto:coursework.scholarships@anu.edu.au">coursework.scholarships@anu.edu.au</a>

There is no separate application form for this scholarship. However, one must submit all the required documents by the deadline published on the scholarship website to complete the application process.

#### 5. SELECTION

Selection is made on the basis of:

- (a) the field of study in which the applicant has expressed interest;
- (b) the availability of appropriate supervision for a scholar in that field of study;
- (c) the applicant's academic record in science;
- (d) supporting material supplied by the applicant which demonstrates the passion for science:
- (e) the reports of two referees familiar with the applicant's academic work and passion for science.

aligned with the University's strategic objectives to ensure a diverse student cohort.

If there are two students of equal merit, preference may be given to a student who plans to undertake study in Physics, recognising Dr Angus Nicholson's own academic interests.

The College Honours Scholarships Committee reserves the right to make no award if it considers there is no applicant of sufficient merit.

#### 6. CONCURRENT HOLDING OF AWARDS

A recipient of the Angus Nicholson Honours Scholarship is permitted to hold concurrent scholarships as outlined in the ANU Coursework Scholarships procedure.

#### 7. DEFERMENT

The recipient is expected to take up their award in the semester for which it is offered. Any requests for deferrals of the award must be approved by the Chair of the College Honours Scholarships Committee. Subject to approval, the award may be deferred for a maximum of one semester.

# 8. ONGOING ELIGIBILITY

A recipient of this award is required to enrol in a full-time load of 24 units per semester. A recipient must request permission, in writing, from the Deputy Dean Education to hold the award on a part-time basis. If approved, payments of the award will be made on a pro-rata basis.

# 9. CESSATION OF AWARD

The award ceases or should be surrendered:

- (a) if a student no longer meets the eligibility requirements
- (b) at the conclusion of the period outlined in section 2; or
- (c) on the date on which the recipient withdraws or ceases to attend the University other than for approved absences;
- (d) if a recipient fails to enrol as required in section 8;

- (e) if a recipient changes to part-time enrolment without receiving permission to retain their scholarship;
- (f) if a recipient changes their program or course without permission;
- (g) if a recipient fails to meet the minimum academic performance requirements;
- (h) if a recipient breaches academic or behavioural standards set by the University under the Academic Misconduct & Discipline Rules;

whichever is earliest.

# **10. REPAYMENT OF FUNDS**

Subject to the information available at the time, The Chair of the College Honours Scholarship Committee may request that the payment for the semester in which the breach of conditions or withdrawal occurs be refunded in part or in full.

## 11. PROVIDING FALSE OR MISLEADING INFORMATION

The awarding of a scholarship/grant is based on the information provided to the University. An award may be withdrawn at any stage if incorrect, false or misleading information is provided or relevant information is withheld. This includes circumstances where the false information is unrelated to the assessment in awarding the scholarship/grant.

## 12. VARIATION TO CONDITIONS OF AWARD

In exceptional circumstances and on a case-by-case basis section 7 of these conditions of award may be varied by the College Dean on the recommendation of the Deputy Dean Education.

# 13. TAXATION & CENTRELINK

Recipients are responsible for seeking taxation and Centrelink advice regarding their own individual circumstances. Scholarships/grants may be regarded as taxable income if a recipient is enrolled on a part-time basis.

#### 15. PUBLICITY

The recipient may be requested to participate in publicity for the award from time to time. This may include publicity in the state or territory of residence or of schooling. Recipients may be contacted for an interview and photograph. The University may also publicise the award by publishing the names of the recipients. Arrangements for such publicity will be made through the Coursework Scholarships Office or Strategic Communications and Public Affairs Office of the University.

#### 16. DISCLOSURE AND DONOR CONTACT

For the purposes of reporting on the impact of scholarships, the name, program name and demographics (for example: age, country or town of residence) relating to a recipient of this award may be disclosed to donors supporting the award. This will not include recipient contact details. The recipient may be asked to write a personal note of thanks or to meet with donors. Any contact between a donor and a recipient will be facilitated by the ANU Advancement Office or an authorised representative of the University.
