ANU COLLEGE OF LAW INTERNATIONAL PATHWAY SCHOLARSHIP CONDITIONS OF AWARD

1. INTRODUCTION

Each year the ANU College of Law may offer a number of awards known as the ANU College of Law International Pathway Scholarship ('the Award').

The objective of the Award is to attract and support top quality international postgraduate students to the ANU College of Law.

Funding for this Award has been provided by the ANU College of Law.

2. BENEFITS

The value of the Award is stated in your letter of offer. The duration of the Award is for one year. The Award is paid in equal instalments after census date of each semester unless otherwise stated in the letter of offer.

The recipient is responsible for making payment of all tuition fees by the prescribed date as set out by the University each session. Recipients of the Award are responsible for the costs of books, study materials, accommodation and all other costs of study including Overseas Student Health Cover (OSHC).

3. ELIGIBILITY

The Award is available to a prospective ANU student who:

- (a) is an International student; and
- (b) has applied to the Master of Laws (LLM) program at the ANU College of Law; and
- (c) has achieved a minimum GPA of 5.0 out of 7.0 (or equivalent) in their relevant undergraduate degree; and
- (d) has graduated from a law program from one of the partner universities listed on the ANU Scholarships website, or will have graduated by the time of taking up the scholarship, and been shortlisted by that university; or
- (e) is a citizen of one of the countries listed on the ANU Scholarships website.

4. APPLICATION

There is no application as students are automatically considered based on them meeting the eligibility criteria or conditions prescribed under the Eligibility section.

5. SELECTION

Selection is made on the basis of applicants meeting the eligibility criteria and academic merit. In the event where academic records are equally ranked, applicants will be asked to submit a short written statement. Other factors such as a letter of recommendation received from the partner university may also be taken into account.

For applicants from a listed partner university, the partner university will shortlist at least two applicants to forward to the ANU College of Law Selection Committee, which will select one recipient from each university.

For applicants from one of the listed countries, the Dean of the ANU College of Law (or nominee) will make the final selection.

The ANU College of Law reserves the right to make no award if it considers there is no applicant of sufficient merit. The ANU College of Law may also vary the number of Awards and/or offer the Award at other times in exceptional circumstances or based on the standard of applications or students (where funds allow).

6. CONCURRENT HOLDING OF AWARDS

A recipient of the Award is permitted to hold concurrent student financial awards as outlined in the ANU Coursework Scholarships procedure.

7. DEFERMENT

The Award cannot be deferred.

8. ONGOING ELIGIBILITY

A recipient of this Award is required to enrol in a full-time load of 24 units per semester. A recipient requests permission, in writing, from the Dean of the ANU College of Law to hold the Award on a part-time basis. If approved, payments of the Award will be made on a pro-rata basis.

9. CESSATION OF AWARD

The Award ceases or should be surrendered:

- (a) if a student no longer meets the eligibility requirements;
- (b) at the conclusion of the period outlined in section 2;
- (c) on the date on which the recipient withdraws or ceases to attend the University other than for approved absences;
- (d) if a recipient fails to enrol as required in section 8;
- (e) if a recipient changes to part-time enrolment without receiving permission to retain the Award;
- (f) if a recipient changes to a program that will not lead to the award of the Master of Laws (LLM);
- (g) if a recipient breaches academic or behavioural standards set by the University under the Academic Integrity Rule and/or the Discipline Rule;

whichever is earliest.

10. REPAYMENT OF FUNDS

Subject to the information available at the time, the Dean of the ANU College of Law may request that the payment for the semester in which the breach of conditions or withdrawal occurs be refunded in part or in full.

11. PROVIDING FALSE OR MISLEADING INFORMATION

The Award is based on the information provided to the University. The Award may be withdrawn at any stage if incorrect, false or misleading information is provided or relevant information is withheld. This includes circumstances where the false information is unrelated to the assessment for the Award.

12. VARIATION TO CONDITIONS OF AWARD

In exceptional circumstances and on a case-by-case basis section 7 of these Conditions of Award may be varied by the Dean of the ANU College of Law on the recommendation of the chair of the selection committee.

13. TAXATION

Recipients are responsible for seeking taxation advice regarding their own individual circumstances. Awards may be regarded as taxable income if a recipient is enrolled on a part-time basis.

14. ACCOMMODATION

It is the recipient's responsibility to obtain residential accommodation. Information on student accommodation and application forms are available from the University Accommodation Services. Information may be found on the Web at:

15. PUBLICITY

The recipient may be requested to participate in publicity for the Award from time to time. This may include publicity in the state or territory of residence or of schooling. Recipients may be contacted for an interview and photograph. The University may also publicise the Award by publishing the names of the recipients. Arrangements for such publicity will be made through the ANU College of Law or ANU Communications and Engagement (ACE).
