I declare that the information provided in this form is true and correct.
If the Australian National University is accepting responsibility for my welfare (Option 3), I understand that until I am 18 I must:

- Regularly monitor my ANU email address, which was created automatically for me
 when I confirmed receipt of my offer of admission. I understand that all official
 ANU communications will be sent to my ANU email address, including requests for
 information and to schedule meetings.
- Provide the ANU Academic Standards and Quality Office (ASQO) details of my travel arrangements prior to my arrival in Australia, and by no later than 5 working days prior to my departure from my home country.
- Arrive in Australia no earlier than the commencement of my CAAW, and no later than Monday of Week 1 in my commencing teaching period (the 'arrival period').
- I understand that I cannot arrive outside of the relevant arrival period.
- Travel directly to Canberra from my home country during the arrival period. If my travel arrangements involve transiting through an Australian city other than Canberra, and this requires an overnight stay at a location other than the approved University accommodation address, I will seek written approval from the Principal Executive Officer (PEO) at least 5 working days prior to my departure from my home country.
- Attend mandatory U18 orientation activities, including, but not limited to, the Under 18 International Student Induction.
- Attend required meetings with the delegated officer within the university residential accommodation, including a meeting in the first week after my arrival, and ongoing meetings every 2 weeks thereafter until I turn 18 years of age.
- Follow the instructions of ANU staff, including, but not limited to, the PEO, delegated officer and staff within ASQO.
- Meet/make contact with my guardian in the first week after my arrival, and every 2 weeks thereafter until I have my 18th birthday.
- Ensure my contact details, including mobile phone number and address, are known by the University, and advise the University of a change in these details within 7 days of the change occurring.
- Obey a curfew of 10pm and not travel outside of Canberra and/or stay away from
 the University-approved accommodation address, including travel outside
 Canberra for the purpose of returning home or tourism, without the prior written
 consent of my parent/legal guardian and the PEO while I am under the age of 18. I
 understand that I must complete an Under-18 International Student Travel
 Approval form and submit this on or prior to 5 business days of departure.
- Live in University-approved accommodation for the duration of the CAAW letter or until the letter is cancelled or changed by the University.

- Not change my welfare arrangements without prior written consent of my parent/legal guardian and the PEO.
- Act responsibly, comply with Australian Law by not participating in illicit activities, and not partake in any risk-taking behaviour.

Section 5: Parent/Legal Guardian Declaration

This form is to be completed and signed by the parent/legal guardian of the student under the age of 18 intending to apply for a student visa to undertake studies at the Australian National University. I understand that the Department of Home Affairs requires the University to approve the living arrangements of students who:

- are under the age of 18;
- are accepting an offer to study at the University; and
- where the University is accepting responsibility for my child's welfare (Option 3), that the student will comply with the conditions listed in this agreement until his/her 18th birthday.

I agree to pay all fees, including tuition fees, the Student Services and Amenities Fee (SSAF) and fees associated with my child residing at University-approved residential accommodation (Option 3), by respective fee payment deadlines.
I acknowledge and agree that, if my child is residing at University-approved residential accommodation (Option 3), I will register them with an ANU approved guardian service and that I am responsible for all associated costs payable.
I acknowledge that where I select either Option 1 or 2, that the University will not be accepting responsibility for my child's welfare. The Department of Home Affairs will approve the welfare and accommodation arrangements and the University is not required to issue a CAAW letter with the Confirmation of Enrolment (CoE).
I give permission for a University internet access account to be created for my child and acknowledge that my child will have unrestricted access to the internet through facilities and services offered by the University.
I declare that when my child arrives in Australia, they will reside in the accommodation option that has been agreed to under Section 3: Accommodation Arrangements from the start date of the CoE or the Nominated Welfare start date. My child/charge will not change his/her accommodation, support and welfare arrangements at any time without the prior written approval of the University.
