## ANU INTERNATIONAL ACHIEVEMENT AWARD

### CONDITIONS OF AWARD

#### 1. INTRODUCTION

The Australian National University (ANU) ('the University') may offer a number of awards known as the ANU International Achievement Award ('the Award').

The objective of the Award is to attract a diverse range of academically capable overseas students to enrol in undergraduate and postgraduate coursework programs offered by the University.

Funding for this Award has been provided by the Australian National University. The Award will be made contingent on the University's confirmed funding allocations.

#### 2. BENEFITS

The value of the Award is stated in the letter of offer. The duration of the Award is for the duration of the program up to a maximum of four years, with the tuition scholarship applied towards tuition at the start of each semester.

The recipient is responsible for making payment of all tuition fees by the prescribed date as set out by the University each session. Recipients of the Award are responsible for the costs of books, study materials, accommodation and all other costs of study.

#### 3. ELIGIBILITY

The Award is available to an ANU student who:

- (a) is an international student;
- (b) is a new commencing student or a continuing student who has received an offer of admission to a higher AQF level of studies;
- (c) holds residential status in a country that is not listed as eligible for the ANU Vice-Chancellor's International Achievement award as detailed on the ANU Scholarships website;
- (d) meets the minimum academic entry requirements:
  - **undergraduate applicants:** a Selection Rank of 85 (or equivalent as determined by the University) or above, or the minimum program entry requirement for applicants who are citizens of a Pacific Region country; or
  - **postgraduate applicants:** a minimum GPA of 5.5 (or equivalent), or the minimum program entry requirement for applicants who are citizens of a Pacific Region country;
- (e) is not the recipient of an [external sponsorship](#) that covers all or part of the students tuition fees at the University; and
- (f) acknowledges that the award can be offered only once at each level of study, except where an applicant progresses from an undergraduate degree (AQF Level

7) to a one-year Honours program (AQF Level 8), or accepts a packaged offer (e.g., a Graduate Certificate leading to a Master's degree).

#### **4. APPLICATION**

There is no application, as students are automatically considered based on meeting the eligibility criteria and conditions prescribed under the Eligibility section.

#### **5. SELECTION**

Only applicants who meet all the eligibility criteria will be considered. Selection is made based on academic merit. Qualifications submitted for admission to the University will be converted to the common scale, which will determine whether an applicant is eligible for the Award. Where an applicant has multiple qualifications, applicants will be ranked according to the qualification used as the basis of admission.

The University reserves the right to make no award where it considers there is no applicant of sufficient merit. The University may also vary the number of Awards and/or offer the Award at other times in exceptional circumstances, or based on the standard of applications or students, where funds allow.

#### **6. CONCURRENT HOLDING OF AWARDS**

A recipient of the Award is permitted to hold concurrent student financial awards as outlined in the [ANU scholarships, grants and bursaries \(coursework\) procedure](#).

#### **7. DEFERMENT**

The Award cannot be deferred.

#### **8. CESSATION OF AWARD**

The Award ceases or should be surrendered:

- (a) if a student no longer meets the eligibility requirements;
- (b) at the conclusion of the period outlined in section 2;
- (c) on the date on which the recipient withdraws or ceases to attend the University other than for approved absences;
- (d) if a recipient breaches academic or behavioural standards set by the University under the Student academic integrity Policy and/or the Discipline Rule;
- (e) if the applicant holds two concurrent ANU academic or sports scholarships including this award, or
- (f) if it is identified that the recipient has breached the financial cap for student financial awards (including scholarships, grants, and bursaries), as outlined in the [University's Student financial](#) awards policy.

whichever is earliest.

#### **9. REPAYMENT OF FUNDS**

Subject to the information available at the time, the Chair of the University Coursework Scholarships Committee or approved nominee may request that the payment for the semester in which the breach of conditions or withdrawal occurs be refunded in part or in full.

#### **10. PROVIDING FALSE OR MISLEADING INFORMATION**

Selection for the Award is based on the information provided to the University. The Award may be withdrawn at any stage if incorrect, false or misleading information is provided or relevant information is withheld. This includes circumstances where the false information is unrelated to the assessment for the Award.

## 11. VARIATION TO CONDITIONS OF AWARD

In exceptional circumstances and on a case-by-case basis, section 7 of these Conditions of Award may be varied by the Deputy Vice-Chancellor (Academic) or their approved nominee.

## 12. TAXATION

Recipients are responsible for seeking independent taxation advice regarding their own individual circumstances. Recipients receiving Centrelink benefits should be aware that student financial awards may affect their Centrelink payments. Student financial awards are generally regarded as taxable income if a recipient is enrolled on a part-time basis.
